# Message from the Executive Committee

As we reflect on the past year, we are proud to highlight the remarkable achievements and progress the Edinburgh Tenants Federation (ETF) has made. Our commitment to advocating for tenants' rights, fostering community engagement, and driving positive change has been steadfast, and we are thrilled to share some of our key accomplishments.



# **Community Engagement and Advocacy**

Over the past year, ETF has actively participated in consultations with the City of Edinburgh Council, the Scottish Government, and the Scottish Parliament, both online and in person. Additionally, we have attended several community events to raise awareness of ETF and engage directly with tenants.

# **Initiatives and Projects**

We successfully launched a Public Information Comic called "Tam's Story," which has been well-received by tenants and stakeholders. This comic serves as an engaging and informative resource, helping tenants understand how they can work within their communities to create positive changes.

# **Strengthening Community Networks**

ETF has been instrumental in setting up new Tenants and Residents Associations in Edinburgh and providing ongoing support to existing ones. This effort has strengthened community networks and empowered tenants to actively improve local services.

# **Digital and Social Media Presence**

Recognizing the importance of digital engagement, ETF has developed a robust social media presence and actively participated in social media campaigns. Our online platforms have become valuable tools for communication, information sharing, and advocacy.

# Staff and Volunteers

There have been several changes within ETF over the last 12 months.

ETF also welcomed a Learning in Communities student from the University of Edinburgh to placement and was on placement between January – June 2024. ETF wish you good luck in your future endeavours.

ETF also want to offer condolences for the loss of George McKie, former ETF Convenor and Jimmy Galloway, who was a valued tenant member, and Neil McCallum who was a former ETF staff member.



# **TIS Awards 2023 and 2024**

ETF staff and volunteers, including members of the Executive Committee, were also able to attend the TIS Annual Conference and Awards in November 2023. ETF had two tenants who were nominated for awards and were finalists. Betty Stone, ETF Convenor, was a finalist for the Outstanding Contribution to Tenant Participation Frances Nelson MBE (Individual Tenant) and Robyn Kane was a finalist, and winner, for the Young Achiever of the Year Award.

# Communications and Social Media

ETF has been working hard to improve its social media engagement and is pleased to report that in the last 12 months, there has been just under a 10% increase in followers on Facebook and around a 5% increase in followers on X (formerly known as Twitter). There has also been an excellent rate of engagement with posts, for example, people have been sharing, liking, and commenting on posts about ETF events which helps get the word out to new people who might not have previously come to ETF events. 

# **Public Information Comic Project**

ETF started a Public Information Comic project in 2023 to create an accessible resource that any tenants and residents in Edinburgh could access and would show how tenants and residents can make an impact in their local communities. Something the tenants involved in this project wanted to do was address the stigma around social tenants and promote ETF. ETF staff asked tenants to provide feedback on several questions about living in social housing, for example, what the good and bad elements of this were.

The tenants worked with ETF staff to create the comic and came up with characters, a setting and a story about a tenant called Tam who wanted to make his area better for his grandchildren, and who would contact ETF to get help to set up a resident's group. The group then looked at local comic artists and commissioned the work from Tanya Roberts, who turned the story into a comic.



The comic will be launched through an event and will be then made available for free to anyone in Edinburgh who wants a copy. If well received, then ETF could potentially create comics on other issues around housing and community in the future.

# Rebranding

ETF has recently started work on a Rebranding project in partnership with TIS, to make improvements to the service, particularly around communications and the use of digital tools and resources for tenants that might make use of.

The Executive Committee will be meeting with ETF and TIS staff to work through the rebranding process so please look out for updates on the rebrand in the coming months.

This year we have held five meetings with the housing officer and Councillor Aston, which have been particularly good. We are celebrating the time we have been a group member of ETF and registered tenants' group with the City of Edinburgh Council. I cannot say enough about the help tenants receive from ETF; without them, we would not have had the things done that we wanted.

# **Birnies Court Tenants & Residents Group**

We have been busy in Birnies Court, there are three groups of mixed people using the community flat. Local people have a different group on a Tuesday, Wednesday & Thursday a craft group, a geography group, and a sewing group. It has been quite quiet at the moment, but there have still been a few issues with repairs which I managed to sort out. I am also dealing with the retrofit going forward in both Oxcars and Inchmickery which will hopefully start in the Spring. I have my regular meeting with the block manager and walkabouts to check the high-rise buildings in the area.
