ETF were delighted to have three guest speakers at the event. PhD student Aaron Sheridan kindly shared his research on council-built communities in Edinburgh, particularly focusing on Wester Hailes. Rock Trust, a youth homelessness charity, engaged attendees with an interactive workshop on facts around youth homelessness and housing. # **Consultations Scottish Housing Regulator Consultation**

ETF held an online session in October 2024 with members to generate an organisational response to the Scottish Parliament Consultation on the Scrutiny of the Scottish Housing Regulator (SHR). Robyn Kane, secretary of ETF, then attended the Scottish Parliament on Tuesday 3rd December to sit on a panel to provide further feedback on the SHR. Robyn raised that the SHR could be doing in



provide further feedback on the SHR. Robyn raised that the SHR could be doing more to push the council to update standards of social housing in Edinburgh. Robyn also shared the ETF Comic, emphasising the need for the SHR to communicate with tenants in different ways to improve engagement. # **Visitor Levy Consultation**

ETF submitted an organisational response to the City of Edinburgh Council Visitor Levy consultation in December 2024. A visitor levy is a payment for people visiting Edinburgh for an overnight stay who are staying in paid accommodation. If councillors decide to adopt this scheme it will come into place in the city from July 2026. One of the suggestions made by ETF members was that the total amount of money raised from the visitor levy that goes towards housing in the city should be increased from the proposed £5 million to £10 million. # **Communal Heating System Charter**

ETF were contacted by the Local Heating Energy Efficiency Strategy (LHEES) team in November 2024 to provide feedback on the Communal Heating System Charter that they are developing. This charter will hopefully ensure stronger regulation of existing and new communal heating systems across Edinburgh. ETF staff have been working to support multiple groups that have had major issues with their communal heating systems, so recognise the challenges that come with the operation of these systems.

# Staying Warm and Saving Money: Home Energy Scotland Support for Tenants

Home Energy Scotland is a valuable resource for tenants in Scotland who are looking to improve their home's energy efficiency and reduce their energy bills. This free and impartial service offers a range of support options tailored to the needs of tenants, including:



**Energy Advice and Support**: Home Energy Scotland advisors can help tenants understand their energy bills, provide tailored advice to help save money and stay warm during the winter.

**Fuel Poverty Advice:** Home Energy Scotland can provide guidance on fuel poverty issues and connect tenants with relevant support services, such as benefits advice and local energy advice providers.

They can also help tenants of private sector landlords access available grants and funding opportunities, such as **Warmer Homes Scotland**. This programme could improve the energy efficiency of properties by funding the installation of measures such as insulation and draught proofing. Making homes warmer, more comfortable, and cheaper to heat. Home Energy Scotland is the only place to access this funding. Home Energy Scotland is the only place to access this funding.



# Heat with Rent Withdrawal in Some Multistorey Blocks

The Council recently wrote to some tenants to let them know that the way they pay for their heating is changing.

Some tenants' home are heated through storage heaters. Tenants pay for their heating through a set weekly charge called Heat with Rent (HWR). The amount tenants are charged depends on how many rooms are in their home.

This change will only affect some tenants who pay the HWR charge and have storage heaters. The Council contacted tenants in December, January and February to let them know about the changes and what they need to do.



This will make sure that they don't end up paying two standing charges. If they don't do anything then Scottish Power (who deliver HWR now) will begin billing them directly for their heating from 1 April.

Radio Teleswitch Service is also being shutdown in June 2025. This is the signal that tells storage heaters when to charge and release heat. This signal is broadcast by the BBC and will be turned off on **30 June**. This may mean that heaters don't function properly. To make sure this doesn't happen, tenants are advised to get smart meters installed.

The Council will contact the tenants who are affected again in March and April. This will remind them of the changes and what they need to do.


In 2024 we also launched free Pet Care Clinics in the community. These are monthly drop-in clinics for any pet owners who want advice and support to care for their pets.

# What a city we live in...

There's so much to admire when walking through Edinburgh. From the majestic views of Arthur's Seat from Dumbiedykes, to the sweeping vistas from the high rises in Moredun, not forgetting the grandeur of the architecture in the city centre that draws the eye upward towards the heavens. Such sights prompted Queen Victoria to breathlessly declare of Edinburgh, "This is a city of shifting light, of changing skies, of sudden vistas. A city so beautiful it breaks the heart again and again."



There is no denying that over 100 years later Queen Victoria's observation still holds true. There is much about the panoramas of our capital to break a romantic's heart. I count myself amongst them. An Irishman, drawn across the sea to this beautiful city, and to one of her bonnie lasses in particular, to make my home here. So often, however, it is for reasons other than the beauty of the city that my heart breaks.

At the coalface of where our beautiful city meets the ugly reality of Scotland's thorny social problems lies the work of the Edinburgh Food Project. Our 7 foodbank centres are simultaneously a source of hope to those in desperate need and a stain on the conscience of a nation that has become increasingly accepting of the presence of foodbanks.

For those living with the ever-present anxiety that poverty brings, there is little time or energy to enjoy what Edinburgh offers. A family trip to marvel at the dinosaur bones in the National Museum, or to feed the animals at Gorgie Farm can feel like an exhausting challenge. For others, meeting friends for coffee at the Botanics is completely out of reach. For people experiencing homelessness or in temporary accommodation, who we see regularly at our Grassmarket foodbank centre, simple pleasures such as a peaceful night's sleep or a quiet night in are beyond the reach of your circumstances. Uncertainty, hunger and loneliness can dog your every moment.

This lack of means shrinks the opportunities that people have to not only enjoy what's on their doorstep, but also to escape their predicament. Preparing for a job interview can be nerve-wracking. But, without smart clothes or the internet to carry out research, the stress increases. Never mind the worry of whether you can afford the bus fare to the interview in the first place.

To paraphrase the old proverb:

For want of a £5 the bus fare was lost.

For want of the bus fare the bus journey was lost.

For want of the journey the job interview was lost.

For want of the job interview the job was lost.

For want of the job the flat was lost.

For want of the flat, stability, safety, the dignity of work, contributing to your community, health...was lost.

And all for the want of £5.



These are the narrow margins many of our fellow citizens live with. The barriers they face are often hidden from those of us who haven't experienced them. Yet, their stories are all too familiar at our foodbanks. The cost-of-living crisis, childcare costs, and precarious, low-paid work are not conducive to long-term planning and the ability for people to not only live with dignity but to achieve their goals.

The Edinburgh Food Project believes it shouldn't be this way, not here, not in our capital, not in 2025. While our foodbanks meet an immediate need by providing emergency food, we offer more than that.



Our in-house Money Advice Service attends each of our foodbanks. Last year, they helped 147 people to claim the benefits and grants they were entitled to. On average, each of those people was £2,300 better off as a result of that support. Not a life-changing sum, but enough to provide financial breathing space to people during a time of crisis.

No one organisation can meet the complex ways poverty affects people's lives. So, alongside our Money Advice Service, we have built partnerships with other fantastic charities. These charities attend our foodbanks, providing support that enables people to navigate the housing system, gain employment and have their voice heard.

In Craigmillar, our Community Hub brings a range of these charities together under one roof. Our simple aim is to act as a resource for the whole community. Here, you can access free housing and energy support, improve your digital skills and get advice on benefits. We understand that loneliness and isolation often accompany living in poverty. At our Hub, you can join one of our community groups that bring people together to learn, have fun, exercise and make friends.

Yes, my heart is more often broken by the stories of those we support than by the view of Arthur's Seat from the top deck of the number 21 bus. However, I'm proud to be part of an organisation working to support people out of poverty and to end people's reliance on foodbanks for good.

We live in a great city; we all should be able to enjoy it.





# The City of Edinburgh Council - Lightning Reach

#### Find financial support this winter

Trying to keep your home warm with rising energy bills can bring added worry in winter. This year, the Council has launched a trial with the Lightning Reach service to help residents find the support that they need. So far, nearly 300 Edinburgh residents have used the service to find financial support.

Lightning Reach matches users to 2500 financial support schemes from charities, organisations and councils. Over £15m has already been awarded to individuals and households, with the successful applicants eceiving £1070 on average.

Under their Winter Warmth Network, there is a wide variety of support available including:

- · energy and bills
- home improvements and energy upgrades
- furniture and white goods
- · warm clothing and essentials.

"There was so much support on the portal that no one had told me about, which is fantastic."

Struggling with rising energy bills and living costs, veteran Darren saw his mental health decline. His debt and increasing expenses triggered his PTSD, making it difficult to support himself and his two children.

Through Lightning Reach, Darren applied to a grant from the Royal British Legion. Within a week, he received energy vouchers that helped him pay off his debt and keep his account in credit. Darren also accessed other support, including disability payments and assistance from his local council and energy provider.

# **Updates from The Advice Shop**

#### Carer Support Payment - replacing Carer's Allowance

Scotland's new Carer Support Payment is being rolled out to replace Carer's Allowance. This payment will provide financial assistance to those who care for someone with a disability or

long-term illness. If you're already receiving Carer's Allowance, you'll be automatically moved to the new benefit in due course. The new payment is administered by Social Security Scotland, providing a more streamlined and accessible service. To be entitled to get Carer Support Payment (CSP) you must:

can help with information, advice and representation

- · be 16 or over
- · usually live in Scotland
- provide care for 35 hours or more a week, this includes if you provide care all day every day
- not earn more than £151 a week after tax, National Insurance and expenses

The person you provide care for must get certain disability benefits such as PIP, DLA, Adult Disability Payment - to see the full list of benefits, check the Social Security Scotland website. It's possible that some people not eligible for Carer's Allowance will be eligible for CSP for example, certain students. To learn more or make an application, visit the Social Security Scotland website or contact their helpline on 0800 182 2222.

#### **Universal Credit Migration**

During 2024 the DWP migrated Tax Credit claimants onto Universal Credit as part of the UK Government's plan to simplify the benefits system.

Now, if you're currently receiving certain 'legacy benefits', such as Employment Support Allowance, Income Support or Housing Benefit, you will be contacted by the DWP about migrating to Universal Credit. It's important to act promptly if you receive a 'Migration Notice', as there's a limited time to make your claim and there are some protections about your level of income that may be lost if the process is not followed.

#### Pension Age Disability Payment – replacing Attendance Allowance

In Scotland Attendance Allowance is being replaced with a new benefit called the Pension Age Disability Payment which will be administrated by Social Security Scotland. This change is part of Scotland's efforts to create 'a fairer and more compassionate social security system'. The new benefit will continue to support older people with disabilities and/or long-term health conditions to cover the extra costs related to their additional needs. Pension Age Disability Payment (PADP) will be available for residents in Edinburgh from 22nd April 2025. You can apply for PADP if you have:

- · reached State Pension age, AND
- had care needs during the day or night for 6 months or more because of a disability or health condition

Those already receiving Attendance Allowance will be moved to PADP automatically by Social Security Scotland unless they contact the DWP about a change of circumstances related to their claim, with no interruption to payments. Keep an eye out for communications from Social Security Scotland regarding this transition.

#### **Pension Credit**

If you're of State Pension age and on a low income, you may qualify for Pension Credit. This benefit not only tops up your income but can also open doors to additional entitlements, such as help with housing costs, free TV licenses, and winter heating payments. Many people miss out on Pension Credit because they don't realise they are eligible. To check if you qualify, you can use the online Pension Credit calculator on the <u>GOV.UK</u> website or contact the Advice Shop on 0131 200 2360 for a free benefit check.

#### **ISS UK Ltd**

The current stair cleaning provider, ISS UK Ltd, has long service in Edinburgh. We'd like to thank them for all the time and effort they've put into helping to keep the city clean over the last 15+ years, including your stairs and the surrounding areas. We'd especially like to thank them for all the emergency cleaning, which would see teams out, across the city, in all weather conditions, including in the middle of the night, dealing with significant cleaning challenges. We wish ISS UK Ltd well with its new, future working focus.

#### Winter cleaning update

Winter weather can disrupt cleaning and schedules. In low temperatures spraying or wet mopping stairs can be unsafe for everyone. Sometimes it can be colder inside the stair than outside, and some areas can be affected more often because they are in higher parts of the city. If the weather is too cold for a full clean, the operatives will still sweep the stairs and remove rubbish. They'll also help with extra tasks like clearing leaves, snow, or gritting footpaths when needed. Missed cleans will be rescheduled for when the weather improves. If several cleans are missed, additional cleaning will be arranged at no extra cost to residents.

#### The cleaning you can expect

The stair cleaning service is provided weekly based on the number of residents contributing towards its cost. Council tenants pay for the service along with their rent. Private owners can opt in, which increases the frequency of cleaning. Owners are billed annually but can arrange to pay in instalments. A basic standard of cleaning is provided to help keep your stairs and surrounding area clean. In addition, deep cleaning and emergency cleaning is provided as required.

Each time the cleaners visit, they will:

- ✓ sweep all staircases and other hard floor areas
- ✓ carefully remove dust, dirt, litter, and any spillages from all floor surfaces
- ✓ apply a deep cleaning agent mixed with cold water to clean and disinfect hard floors
- ✓ if needed, wet scrub stairs, landings, and deck access areas to remove dirt and soil stuck to surfaces
- ✓ finish by mopping with clean water. Any splashes will be removed with dry mopping at the end
- √ wipe down handrails with a damp cloth
- ✓ clean window ledges and dados, removing dust, debris, and cobwebs
- √ sweep and wash front and back steps, including porches and platforms.

Note: Cleaners will only move mats; any other items left on the stairs by residents will be cleaned around. The standard clean does not include ledges above residents' doors, walls, balustrades, or high-level dusting.


